A BILL FOR AN ACT

To amend Public Law No. 7-96 by amending sections 1 and 5, and by adding a new section 5, for the purpose of modifying the use of certain funds previously appropriated therein, by renumbering section 6, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-96 is hereby amended to  
2 read as follows:

3 "Section 1. Elementary and secondary education needs in  
4 Chuuk. The sum of ~~\$915,000~~ 900,000, or so much thereof as  
5 may be necessary, is hereby appropriated from the General  
6 Fund of the Federated States of Micronesia for the fiscal  
7 year ending September 30, 1993, for the purpose of funding  
8 elementary and secondary education needs in Chuuk State.

9 The sum appropriated by this section shall be apportioned as  
10 follows:

23 be necessary, is hereby appropriated from the General Fund  
24 of the Federated States of Micronesia for the fiscal year  
25 ending September 30, 1993, for the purpose of promoting the

2           Section 3. Section 5 of Public Law No. 7-96 is hereby amended  
3 to read as follows:  
4           "Section §6. All funds appropriated by this act shall be  
5 allotted, managed, administered, and accounted for in  
6 accordance with applicable law, including, but not limited  
7 to, the Financial Management Act of 1979. The allottee of  
8 the funds appropriated under subsections (1) and (2) of  
9 section 1 of this act shall be the respective school board  
10 of each institution; the allottee of the funds appropriated  
11 under subsection (4) of section 1 of this act shall be the  
12 Southern Namoneas Development Authority; the allottee of  
13 the funds appropriated under subsection (5) of section 1 of  
14 this act shall be the President of the Federated States of  
15 Micronesia or the President's designee; and the allottee of  
16 the remaining subsections of section 1 shall be the  
17 Governor of Chuuk State. The President or the President's  
18 designee shall be the allottee of the funds appropriated  
19 under sections 2 and 4 of this act. The allottee of the  
20 funds appropriated under subsections (1) and (3) of section  
21 3 of this act shall be the Governor of Pohnpei State or his  
22 designee. The allottee of the funds appropriated under  
23 subsections (2) and (4) of section 3 of this act shall be  
24 the Pohnpei Community Action Agency. The allottee of the  
25 funds appropriated under section 5 of this act shall be the

1            Lower Mortlocks Development Authority. The allottees shall  
2            be responsible for ensuring that these funds, or so much  
3            thereof as may be necessary, are used solely for the  
4            purpose specified in this act, and that no obligations  
5            are incurred in excess of the sum appropriated. The  
6            authority of the allottees to obligate funds appropriated  
7            by this act shall lapse as of September 30, 1994."

8            Section 4. Section 6 of Public Law No. 7-96 is hereby renumbered  
9 as section 7.

10           Section 5. This act shall become law upon approval by the  
11 President of the Federated States of Micronesia or upon its becoming  
12 law without such approval.
