**PRESIDENTIAL COMM. NO. 7-383**  
**FSM CONGRESS**

To further amend Public Law No. 7-24, as amended by Public Laws Nos. 7-63, 7-74 and 7-84, Pohnpei State public projects, by further amending section 5, as amended by Public Laws Nos. 7-63, 7-74 and 7-84, to modify the allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 7-24, as amended by  
2 Public Laws Nos. 7-63, 7-74 and 7-84, is hereby further amended to  
3 read as follows:

4 "Section 5. All funds appropriated by this act shall be  
5 allotted, managed, administered, and accounted for in  
6 accordance with applicable law, including, but not limited  
7 to, the Financial Management Act of 1979. The allottee of  
8 the funds appropriated under subsections (6), (7), (8),  
9 (9), (10), (11), (12) and (13) of section 1 of this act  
10 shall be the President of the Federated States of  
11 Micronesia. The allottee of the funds appropriated under  
12 subsection (1) of section 2 of this act shall be the  
13 Meninkederlapalap of the Municipality of Madolenihmw. The  
14 allottee of the funds appropriated under subsection (2) of  
15 section 2 of this act shall be the Lukenmoanlap of the  
16 Municipality of Kitti. The allottees of the funds  
17 appropriated under section 2 of this act shall submit  
18 detailed funds status and project status reports to the  
19 Congress of the Federated States of Micronesia at the  
20 beginning of each quarter of each fiscal year until the  
21 funds appropriated thereunder are fully expended. The  
22 allottee of the funds appropriated under subsection (15) of



1 section 1 and under section 4 of this act shall be the  
2 Governor of Pohnpei State. The allottee of the funds  
3 appropriated under subsection (1) of section 1 of this act  
4 shall be the Pohnpei State PTA. The allottee of the funds  
5 appropriated under subsection (2) of section 1 of this act  
6 shall be the Mayor of Kolonia Town. The allottee of the  
7 funds appropriated under subsections (3), (17) and (18) of  
8 section 1 of this act shall be the Chief Magistrate of  
9 Sokehs Municipality. The allottee of the funds  
10 appropriated under subsections (4), (14), (16) and (19) of  
11 section 1 of this act and under section 3 of this act shall  
12 be the Pohnpei Community Action Agency. The allottee of  
13 the funds appropriated under subsection (5) of section 1 of  
14 this act shall be the Luhkenkolwof of Sapwuahfik  
15 Municipality. The allottees shall be responsible for  
16 ensuring that these funds, or so much thereof as may be  
17 necessary, are used solely for the purposes specified in  
18 this act, and that no obligations are incurred in excess of  
19 the sum appropriated. The authority of the allottees to  
20 obligate funds appropriated by this act shall not lapse."


