C.R. NO. 7-144

A RESOLUTION

Directing the President to denounce and withdraw from the Treaty on Fisheries Between the Government of Certain Pacific Island States and the Government of the United States of America.

- 1 WHEREAS, the Federated States of Micronesia is party to a multi-
- 2 lateral convention entitled the Treaty on Fisheries Between the
- 3 Governments of Certain Pacific Island States and the Government of
- 4 the United States of America; and
- 5 WHEREAS, said agreement establishes the terms under which
- 6 nationals and vessels of the United States of America may fish within
- 7 the Exclusive Economic Zone of the Federated States of Micronesia and
- 8 certain other Pacific nations; and
- 9 WHEREAS, it is Congress's determination that the compensation
- 10 received by this Nation pursuant to the treaty does not adequately
- 11 compensate it for the exploitation of our resources that is
- 12 permitted pursuant to the treaty, and the interests of the Nation
- 13 would be furthered by withdrawing from or denouncing the treaty and
- 14 negotiating separate agreements with the United States purse seine
- 15 owners; and
- 16 WHEREAS, the treaty, according to its terms, contains no
- 17 certain expiration date, but permits states, pursuant to section
- 18 12.7 to unilaterally withdraw from or denounce such treaty by
- 19 depositing an instrument signifying such withdrawal or denunciations
- 20 with the depositary of the treaty; and
- 21 WHEREAS, pursuant to section 2 of article IX of the
- 22 Constitution of the Federated States of Micronesia, Congress is given
- 23 the authority to determine the treaties by which the Nation should be
- 24 bound; now, therefore,
- 25 BE IT RESOLVED by the Seventh Congress of the Federated States
