

A BILL FOR AN ACT

To further amend Public Law No. 5-80, as amended, by further amending section 2, as amended by Public Laws Nos. 5-108, 6-34, 7-50, 7-65, 7-94 and 7-134, for the purpose of modifying the use of funds previously appropriated for public projects in Kosrae State, and by further amending section 3, as amended by Public Laws Nos. 6-34, 7-15, 7-52, and 7-94, for the purpose of changing the allottee of certain projects appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 5-80, as amended by Public
2 Laws Nos. 5-108, 6-34, 7-50, 7-65, 7-94 and 7-134, is hereby further
3 amended to read as follows:

4 "Section 2. The sum appropriated under section 1 of this


17 Section 2. Section 3 of Public Law No. 5-80, as amended by
18 Public Laws Nos. 6-34, 7-15, 7-52 and 7-94, is hereby further amended
19 to read as follows:

20 "Section 3. All funds appropriated by this act shall be
21 allotted, managed, administered, and accounted for in
22 accordance with applicable law, including, but not limited
23 to, the Financial Management Act of 1979. The allottee of
24 the funds appropriated under section 2 of this act shall be
25 the Governor of the State of Kosrae; except, however, that

1 the allottee of the funds appropriated under subsections
 2 (1), (2), (3), ~~(4)~~ (4)(a), (4)(b), (4)(c), (4)(d), (4)(e),
 3 (4)(f), (4)(g), (4)(h), (4)(i), (5)(a), (5)(c), (5)(d),
 4 (6), (7), (11) and (12) of section 2 of this act shall be
 5 the Chairman of the Kosrae Small Improvement Projects
 6 Commission, the allottee of the funds appropriated under
 7 subsection (4)(j) of section 2 of this act shall be the
 8 Mayor of Malem Municipality, and that the allottee of the
 9 funds appropriated under subsection (5)(b) of section 2 of
 10 this act shall be the Mayor of Utwe Municipality. Each
 11 allottee shall be responsible for ensuring that these
 12 funds, or so much thereof as may be necessary, are used
 13 solely for the purposes specified in this act, and that no
 14 obligations are incurred in excess of the sum
 15 appropriated. The authority of the allottees to obligate
 16 funds appropriated by this act shall not lapse until
 17 expended."

18 Section 3. This act shall become law upon approval by the
 19 President of the Federated States of Micronesia or upon its becoming
 20 law without such approval.
