A BILL FOR AN ACT

To further amend Public Law No. 2-34, as amended, by further amending section 1, as amended by Public Laws Nos. 2-44, 3-12, 3-35, 3-50, 4-79, 5-11 and 6-106, to further change the purpose of the funds appropriated thereby for certain public projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 2-34, as amended by  
2       Public Laws Nos. 2-44, 3-12, 3-35, 3-50, 4-79, 5-11, and 6-106, is  
3       hereby further amended to read as follows:

4                 "Section 1. The sum of \$846,200, or so much thereof as may  
5       be necessary, is hereby appropriated from the General Fund  
6       of the Federated States of Micronesia for the fiscal year  
7       ending September 30, 1982, for the purpose of funding  
8       certain public projects in the State of Truk. The sum  
9       appropriated by this section shall be apportioned as  
10      follows:
