

A BILL FOR AN ACT

To amend Public Law No. 8-24 by amending section 2 for the purpose of modifying funds previously appropriated for the Mortlocks in Chuuk State, by amending section 3 for the purpose of changing the allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 8-24 is hereby amended to read as follows:

"Section 2. The sum appropriated under section 1 of this act shall be apportioned as follows:

- (1) Chuuk State
 - (a) Faichuk

23	Section 2. Section 3 of Public Law No. 8-24 is hereby amended	
24	to read as follows:	
25	"Section 3. All funds appropriated by this act shall be	

1 allotted, managed, administered, and accounted for in
2 accordance with applicable law, including, but not limited
3 to, the Financial Management Act of 1979. The allottee of
4 the funds appropriated under subsection (1)(a) of section 2
5 of this act shall be the Faichuk PWP Development Authority.
6 The allottee of the funds appropriated under subsection (1)
7 (b) of section 2 of this act shall be the Secretary of the
8 Department of Health Services. The allottee of the funds
9 appropriated under subsection ~~1(f)~~ (1)(c) of section 2 of
10 this act shall be the Lower Mortlocks Development Authority. The
11 allottee of the funds appropriated under subsection (1)(d)(i)
12 of section 2 of this act shall be the Hall Islands Development
13 Authority. The allottee of the funds appropriated under
14 subsection (1)(d)(ii) of section 2 of this act shall be the
15 Nomunwito Development Authority. The allottee of the funds
16 appropriated under subsections (1)(d)(iii) and (1)(d)(iv) of
17 section 2 of this act shall be the Pattiw Development Authority.
18 The allottee for all other funds appropriated under this act
19 shall be the President or the President's designee;
20 PROVIDED, the allottee of the funds appropriated under
21 subsection (3) of section 2 of this act shall be the
22 Governor of the State of Yap. The allottees shall be
23 responsible for ensuring that these funds, or so much
24 thereof as may be necessary, are used solely for the
25 purposes specified in this act, and that no obligations are

1 incurred in excess of the sum appropriated. The authority
2 of the allottees to obligate funds appropriated by this act
3 shall lapse as of September 30, 1995."

4 Section 3. This act shall become law upon approval by the
5 President of the Federated States of Micronesia or upon its becoming
6 law without such approval.
