A BILL FOR AN ACT

To appropriate the sum of \$50,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, for the purpose of funding a Traditional Leaders Conference to be held in Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$50,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1994, for the purpose of funding a Traditional Leaders Conference
- 5 to be held in Pohnpei.
- 6 Section 2. All funds appropriated by this act shall be allotted,
- 7 managed, administered, and accounted for in accordance with applicable
- 8 law, including, but not limited to, the Financial Management Act of
- 9 1979. The allottee of the funds appropriated under section 1 of this
- 10 act shall be the President of the Federated States of Micronesia. The
- 11 allottee shall be responsible for ensuring that these funds, or so
- 12 much thereof as may be necessary, are used solely for the purpose
- 13 specified in this act, and that no obligations are incurred in excess
- 14 of the sum appropriated. The authority of the allottee to obligate
- 15 funds appropriated by this act shall not lapse.
- 16 Section 3. This act shall become law upon approval by the
- 17 President of the Federated States of Micronesia or upon its becoming

A BILL FOR AN ACT

To further amend Public Law No. 5-118, Kosrae State public projects, as amended by Public Laws Nos. 6-40 and 7-13, by further amending section 3, as amended by Public Laws Nos. 6-40 and 7-13, for the purpose of changing the allottee of certain projects appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 5-118, as amended by
2	Public Laws Nos. 6-40 and 7-13, is hereby further amended to read as
3	follows:
4	"Section 3. All funds appropriated by this act shall be
5	allotted, managed, administered, and accounted for in
6	accordance with applicable law, including, but not limited
7	to, the Financial Management Act of 1979. The allottee of
8	the funds appropriated under subsections (1) and (2) of
9	section 2 of this act shall be the Governor of the State of
10	Kosrae. The allottee of the funds appropriated under
11	subsection (3) of section 2 of this act shall be the
12	Chairman of the Kostae State Commission on Improvement
13	Projects Mayor of Lelu. Each allottee shall be responsible
14	for ensuring that these funds, or so much thereof as may be
15	necessary, are used solely for the purposes specified in
16	this act, and that no obligations are incurred in excess of
17	the sum appropriated. The authority of the allottees to
18	obligate funds appropriated by this act shall not lapse
19	until expended."
20	Section 2. This act shall become law upon approval by the
21	President of the Federated States of Micronesia or upon its becoming
22	law without such approval.

The allottee of the funds appropriated under section 1 of this act shall be the President of the Federated States of Micronesia. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess 13 of the sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall not lapse. 15 16 Section 3.
