A BILL FOR AN ACT

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$11,242, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1994, for the purpose of providing funding for the Micronesian Day
- 5 Event in Guam.
- 6 Section 2. All funds appropriated by this act shall be allotted,
- 7 managed, administered, and accounted for in accordance with applicable
- 8 law, including, but not limited to, the Financial Management Act of
- 9 1979. The allottee shall be responsible for ensuring that these
- 10 funds, or so much thereof as may be necessary, are used solely for
- 11 the purpose specified in this act, and that no obligations are
- 12 incurred in excess of the sum appropriated. The authority of the
- 13 allottee to obligate funds appropriated by this act shall lapse as
- 14 of September 30, 1994.
- 15 Section 3. This act shall become law upon approval by the
- 16 President of the Federated States of Micronesia or upon its becoming
- 17 law without such approval.
