- 8 granted to him by said section 204 of title 7 of the Code of
- 9 the Federated States of Micronesia.
- 10 Section 2. This act shall become law upon approval by the
- 11 President of the Federated States of Micronesia or upon its
- 12 becoming law without such approval.
