A BILL FOR AN ACT

To amend Public Law No. 8-93 by amending section 1 for the purpose of further specifying the apportionment of certain funds previously appropriated for school needs throughout the Federated States of Micronesia, by amending section 2 for the purpose of designating the allottees of said funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 8-93 is hereby amended to read as follows:

"Section 1. The sum of \$1,300,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for school needs throughout the Federated States of Micronesia. The funds appropriated under this act shall be apportioned as follows:

25 Section 2. Section 2 of Public Law No. 8-93 is hereby amended to

1 read as follows:

2 "Section 2. All funds appropriated by this act shall be
3 allotted, managed, administered, and accounted for in accordance
4 with applicable law, including, but not limited to, the Financial
5 Management Act of 1979. The allottee of the funds appropriated
6 under subsections (1)(d)(i) ~~through (1)(d)(vi)~~ of section 1 of
7 this act shall be the Weito Development Authority. The allottee
8 of the funds appropriated under subsection ~~(1)(d)(vii)~~ (1)(d)(ii)
9 of section 1 of this act shall be the Pattiw Development
10 Authority. The allottee of the funds appropriated under
11 subsection (1)(e)(xiii) of section 1 of this act shall be the
12 Lower Mortlocks Development Authority. The allottee of all other
13 funds appropriated by this act shall be the President of the
14 Federated States of Micronesia or the President's designee. The
15 allottees shall be responsible for ensuring that these funds, or
16 so much thereof as may be necessary, are used solely for the
17 purposes specified in this act, and that no obligations are
18 incurred in excess of the sum appropriated. The authority of the
19 allottees to obligate funds appropriated by this act shall not
20 lapse."
