## A BILL FOR AN ACT

To further amend Public Law No. 7-96, as amended by Public Laws Nos. 7-126, 8-4, 8-8, 8-23, and 8-88, by further amending section 6, as amended by Public Laws Nos. 7-126, 8-8, and 8-88, to remove the lapse date therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 6 of Public Law No. 7-96, as amended by
2	Public Laws Nos. 7-126, 8-8 and 8-88, is hereby further amended
3	to read as follows:
4	"Section 6. All funds appropriated by this act shall be
5	allotted, managed, administered, and accounted for in
6	accordance with applicable law, including, but not
7	limited to, the Financial Management Act of 1979.
8	The allottee of the funds appropriated under
9	subsections (1) and (2) of section 1 of this act shall
10	be the respective school board of each institution; the
11	allottee of the funds appropriated under subsection
12	(4) of section 1 of this act shall be the Southern
13	Namoneas Development Authority; the allottee of the
14	funds appropriated under subsection (5) of section 1
15	of this act shall be the President of the Federated
16	States of Micronesia or the President's designee; the
17	allottee of the funds appropriated under subsection
18	(6) of section 1 of this act shall be the Lower
19	Mortlocks Development Authority; the allottee of the
20	funds appropriated under subsections (7)(b) and 7(c)
21	of section 1 of this act shall be the Pattiw Social and
22	Economic Development Authority; and the allottee of
23	the remaining subsections of section 1 shall be the
24	Governor of Chuuk State. The President or the
25	President's designee shall be the allottee of the funds

1	appropriated under sections 2 and 4 of this act. The
2	allottee of the funds appropriated under subsections
3	(1) and (3) of section 3 of this act shall be the
4	Governor of Pohnpei State or his designee. The
5	allottee of the funds appropriated under subsections
6	(2) and (4) of section 3 of this act shall be the
7	Pohnpei Community Action Agency. The allottee of the
8	funds appropriated under section 5 of this act shall be
9	the Lower Mortlocks Development Authority. The
10	allottees shall be responsible for ensuring that these
11	funds, or so much thereof as may be necessary, are
12	used solely for the purpose specified in this act, and
13	that no obligations are incurred in excess of the sum
14	appropriated. The authority of the allottee to obligate
15	funds appropriated by this act shall not lapse as of
16	September 30, 1994."
17	Section 2. This act shall become law upon approval by the
18	President of the Federated States of Micronesia or upon its
19	becoming law without such approval.
