All funds appropriated by this act shall be allotted, managed, 3 administered, and accounted for in accordance with applicable law, including, 4 but not limited to, the Financial Management Act of the 1979. The allottee of 5 the funds appropriated under sections 1 and 2 of this act shall be the President 6 of the Federated States of Micronesia or the President's designee. The allottee 7 of the funds appropriated under section 3 of this act shall be the Pohnpei 8 Transportation Authority. The allottees shall be responsible for ensuring that 9 these funds, or so much thereof as may be necessary, are used solely for the 10 purposes specified in this act, and that no obligations are incurred in excess of 11 the sum appropriated. The authority of the allottees to obligate funds 12 appropriated by this act shall not lapse. 13 Section 5.
