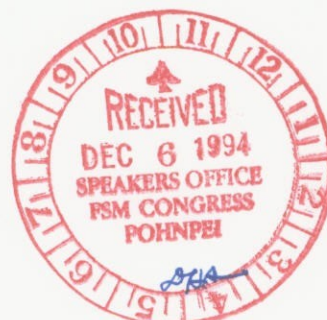


## AN ACT

To further amend Public Law No. 6-49, as amended, by further amending section 1, as amended by Public Laws Nos. 6-55, 6-96 and 7-57, to modify the use of funds appropriated therein for Chuuk State public projects, by further amending section 2, as amended by Public Law No. 6-55, to modify the use of funds previously appropriated for public projects in the Northern Namoneas region of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1       Section 1. Section 1 of Public Law No. 6-49, as amended by Public Laws  
2       Nos. 6-55, 6-96 and 7-57, is hereby further amended to read as follows:
- 3       "Section 1. Statewide public projects. The sum of \$200,000, or so  
4       much thereof as may be necessary, is hereby appropriated from the  
5       General Fund of the Federated States of Micronesia for the fiscal year  
6       ending September 30, 1990, for the purpose of funding certain  
7       statewide public projects in Chuuk State. The sum appropriated by this  
8       section shall be apportioned as follows:
- 9               (1) Vehicle for Chuuk State medical  
10              referral office in Honolulu.....\$   15,773.96
- 11              (2) TOCA - Rural water system.....   21,006.35
- 12              (3) UFO School - Fefan.....   14,562.31
- 13              (4) Library - Mortlocks Jr. High School.....   20,000.00
- 14              (5) Farmers Home Administration -  
15              Chuuk Office.....   6,000.00
- 16              (6) Weno Constitutional Convention.....   10,000.00
- 17              (7) Chuuk Federation of Fishing Co-op.....   7,000.00

 12 6-55, is hereby further amended to read as follows:

13 "Section 2. Northern Namoneas public projects. The sum of \$400,000,  
 14 or so much thereof as may be necessary, is hereby appropriated from  
 15 the General Fund of the Federated States of Micronesia for the fiscal  
 16 year ending September 30, 1990, for the purpose of funding certain  
 17 public projects in Northern Namoneas, Chuuk State. The sum  
 18 appropriated by this section shall be apportioned as follows:



