20	to read a	s follows:
21		"Section 3. All funds appropriated by this act shall be
22		allotted, managed, administered, and accounted for in
23		accordance with applicable law, including, but not limited
24		to, the Financial Management Act of 1979. The allottee of
25		the funds appropriated under subsection (1)(a) of section 2

of this act shall be the PWP Development Authority. The
allottee of the funds appropriated under subsection (1)(b)
of section 2 of this act shall be the Secretary of
Education of the Federated States of Micronesia. The
allottee of the funds appropriated under subsection (1)(c)
of section 2 of this act shall be the Lower Mortlocks
Development Authority. The allottee of the funds appropriated
under subsection (1)(e) of section 2 of this act shall be the
Pattiw Development Authority. The allottee of the funds
appropriated under subsection (1)(f) of section 2 of this act
shall be the Saramen Chuuk Academy Board of Directors. The
allottee of all other funds appropriated under section 2 of
this act shall be the President or the President's designee,
except that for Pohnpei State funds to be disbursed to
Nett, U, Mwoakilloa and Pingelap, the allottee shall be
the Pohnpei Community Action Agency, and funds to be
disbursed to Madolenihmw and Kitti, the allottees for
which shall be the respective chief magistrates; PROVIDED,
the allottee of the funds appropriated under subsection (3)
of section 2 of this act shall be the Governor of the State
of Yap. The allottees shall be responsible for ensuring
that these funds, or so much thereof as may be necessary,
are used solely for the purpose specified in this act, and
that no obligations are incurred in excess of the sum
appropriated. The authority of the allottees to obligate

1	funds appropriated by this act shall lapse as of
2	September 30, 1995."
3	Section 3. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its becoming
5	law without such approval.
