AN ACT

To further amend Public Law No. 8-18, as amended by Public Laws Nos. 8-39, 8-44, 8-51 and 8-73, by further amending section 2, as amended by Public Law No. 8-51, to appropriate the sum of \$236,705 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, as supplemental funding for the operations of the legislative branch; by further amending section 15, as amended by Public Law No. 8-39, to raise the overtime ceiling for the Congress; and for other purposes.
