## A RESOLUTION

To ratify the Articles of Agreement establishing the Arrangement for the Management of the Western Pacific Purse Seine Fishery.

- WHEREAS, the Articles of Agreement establishing the
- 2 Arrangement for the Management of the Western Pacific Purse
- 3 Seine Fishery was signed by most governments who are parties to
- 4 the Nauru Agreement (PNA), which includes the Federated States
- 5 of Micronesia, the Republic of Palau, Papua New Guinea, the
- 6 Republic of the Marshall Islands, the Republic of Nauru and
- 7 Tuvalu on October 28, 1992; and
- 8 WHEREAS, the general functions of the Management Meeting
- 9 include consideration of all available information relating to
- 10 catch and operations of purse seine fishing vessels within the
- 11 area, and economic and socio-economic information relating to
- 12 the impact of the fishing on parties; establishing necessary
- 13 measures for the management of purse seine fishing efforts,
- 14 allocation of licenses, closed areas and other management
- 15 measures from time to time; the establishment and implementation
- 16 of a system of observation and inspection consistent with
- 17 regionally agreed-upon initiatives; the more effective
- 18 implementation of the first and second implementing arrangements
- 19 entered into pursuant to the Nauru Agreement Concerning
- 20 Cooperation in the Management of Fisheries of Common Interest;
- 21 1982; the development of surveillance and enforcement procedures
- 22 consistent with regionally agreed-upon initiatives; referral of
- 23 matters for consideration by Special Working Groups; the
- 24 adoption of a budget for the management of tuna resources; and
- 25 the determination of the level of contributions by parties; and

WHEREAS, the scope of the arrangement shall apply to all 1 species of tuna and tuna-like species taken by purse seine vessels, wherever they may occur in the area; and WHEREAS, this Arrangement will enter into force 14 days 4 following receipt by the depository of the instruments of ratification by the signatory governments; and 7 WHEREAS, it is in the best interest of the National 8 Government of the Federated States of Micronesia to ratify an Arrangement for the management of the purse seine fishery; now, 10 therefore, BE IT RESOLVED by the Eighth Congress of the Federated States of 11 Micronesia, Fitst Second Regular Session, 1993, that pursuant 12 13 to section 2(b) of article IX of the Constitution of the 14 Federated States of Micronesia the Congress hereby ratifies the Articles of Agreement establishing the Arrangement for the 15 16 Management of the Western Pacific Purse Seine Fishery; and BE IT FURTHER RESOLVED that upon receipt of this resolution 17 the President of the Federated States of Micronesia is hereby 18 authorized to designate the Secretary of External Affairs to 19 lodge a document of ratification with the depository; and 20 21 22 23 • 24 25
