## A RESOLUTION

Directing the President to decline the offer of a loan from the Government of the People's Republic of China for the reason that the restrictions imposed on the use of the funds are inconsistent with the National goals and priorities of the Federated States of Micronesia and constitute a serious affront and insult to the dignity of the Federated States of Micronesia as a sovereign and independent nation.

1	WHEREAS, the Government of the People's Republic of China
2	proposed to extend a loan to the Government of the Federated
3	States of Micronesia, in the sum of US \$2,000,000, for the purpose
4	of constructing a "Convention Center and Museum", and said
5	Governments have negotiated an agreement formalizing the
6	intentions of the parties with respect to the general terms of the
7	loan; and
8	WHEREAS, the Congress of the Federated States of Micronesia,
9	in consultation with other divisions and departments of the
LO	National Government, determined that there is a pressing need for
11	a multipurpose facility at the new College of Micronesia - FSM
12	campus, which would serve not only as a gymnasium and auditorium
13	for the students and the citizens of Pohnpei, but would be
L4	suitable for use as a convention center as well; and
15	WHEREAS, the Constitution of the Federated States of
16	Micronesia mandates, under sections 2 and 3 of article IX, that
L7	Congress alone has the power to ratify agreements made by the
L 8	Executive with foreign governments and to borrow money on the
L9	public credit at the National level; and
20	WHEREAS, in light of the foregoing, the Congress of the
21	Federated States of Micronesia made it known to the Government of
22	the People's Republic of China that it would ratify the loan
23	agreement on condition that the parties agree that the money be
24	used for a multipurpose meeting facility on the site of the new
25	College of Micronesia-FSM campus under construction at Palikir;

2	WHEREAS, the Government of the People's Republic of China
3	has without reason or explanation refused to so modify the
4	agreement in disregard of the wishes of the elected
5	representatives of the people of the Federated States of
6	Micronesia, and in disregard as well of the Nation's priority on
7	developing its educational infrastructure; now, therefore,
8	BE IT RESOLVED by the Eighth Congress of the Federated
9	States of Micronesia, Third Special Session, 1995, that the
10	President be directed to advise the Government of the People's
11	Republic of China that the Federated States of Micronesia must
12	categorically decline the offer of the loan as tendered, for the
13	reason that the terms and restrictions imposed by the lender on
14	the use of the funds are inconsistent with the National goals and
15	priorities of the Federated States of Micronesia, and constitute a
16	serious affront and insult to the dignity of the Federated States
17	of Micronesia as a sovereign and independent nation in the
18	international community; and
19	BE IT FURTHER RESOLVED that certified copies of this
20	resolution be transmitted to the President of the Federated States
21	of Micronesia, the Secretary of the Department of External
22	Affairs, and the Government of the People's Republic of China.
