A BILL FOR AN ACT

To further amend Public Law No. 5-80, as amended, by further amending section 3, as amended by Public Laws Nos. 6-34, 7-15, 7-52, 7-94, 8-1 and 8-35, for the purpose of changing the allottee of funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 5-80, as amended by
2 Public Laws Nos. 6-34, 7-15, 7-52, 7-94, 8-1 and 8-35, is hereby
3 further amended to read as follows:

4 "Section 3. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in
6 accordance with applicable law, including, but not limited
7 to, the Financial Management Act of 1979. The allottee of
8 the funds appropriated under section 2 of this act shall be
9 the Governor of the State of Kosrae; except, however, that
10 the allottee of the funds appropriated under subsections
11 (1), (6), (11) and (12) of section 2 of this act shall be
12 the Chairman of the Kosrae State Commission on Improvement
13 Projects, the allottee of the funds appropriated under
14 subsection (2) of section 2 of this act shall be the Mayor
15 of ~~Vela~~ Tafunsak Municipality, the allottee of the funds
16 appropriated under subsection (3) of section 2 of this act
17 shall be the Mayor of ~~Tafunsak~~ Lelu Municipality, the
18 allottee of the funds appropriated under subsection (4) of
19 section 2 of this act shall be the Mayor of Malem
20 Municipality, the allottee of the funds appropriated under
21 subsection (5) of section 2 of this act shall be the Mayor
22 of Utwe Municipality, and the allottee of the funds
23 appropriated under subsection (7) of section 2 of this act
24 shall be the President of the Federated States of
25 Micronesia. Each allottee shall be responsible for

1 ensuring that these funds, or so much thereof as may be
2 necessary, are used solely for the purposes specified in
3 this act, and that no obligations are incurred in excess of
4 the sum appropriated. The authority of the allottees to
5 obligate funds appropriated by this act shall not lapse
6 until expended."

7 Section 2. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its becoming
9 law without such approval.
