
AN ACT

To appropriate the sum of \$45,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, for the purpose of travel and supplies for the Presidential Task Force on Restructuring Government, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$45,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 1994, for the purpose of travel and supplies for the
5 Presidential Task Force on Restructuring Government.

6 Section 2. All funds appropriated by this act shall be
7 allotted, managed, administered, and accounted for in accordance
8 with applicable law, including, but not limited to, the Financial
9 Management Act of 1979. The allottee shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary,
11 are used solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum appropriated.
13 The authority of the allottee to obligate funds appropriated by
14 this act shall not lapse.

15 Section 3. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its
17 becoming law without such approval.

AN ACT

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$45,000, or so much thereof as may be

6 Section 2. All funds appropriated by this act shall be

8 with applicable law, including, but not limited to, the Financial
9 Management Act of 1979. The allottee shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary,
11 are used solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum appropriated.
13 The authority of the allottee to obligate funds appropriated by
14 this act shall not lapse.

15 Section 3. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its
17 becoming law without such approval.
