

A BILL FOR AN ACT
PAC No. 8-~~110~~

To further amend Public Law No. 7-24, as amended, Pohnpei State public projects, by further amending section 5, as amended by Public Laws Nos. 7-63, 7-74, 7-84 and 7-105, to modify the allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 7-24, as amended by
2 Public Laws Nos. 7-63, 7-74, 7-84 and 7-105, is hereby further amended
3 to read as follows:

4 "Section 5. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in
6 accordance with applicable law, including, but not limited
7 to, the Financial Management Act of 1979. The allottee of
8 the funds appropriated under subsections (6), (7), (8),
9 (9), (10), (11), (12) and (13) of section 1 of this act and
10 under section 3 of this act shall be the President of the
11 Federated States of Micronesia. The allottee of the funds
12 appropriated under subsection (1) of section 2 of this act
13 shall be the Meninkederlapalap of the Municipality of
14 Madolenihmw. The allottee of the funds appropriated under
15 subsection (2) of section 2 of this act shall be the
16 Lukenmoanlap of the Municipality of Kitti. The allottees
17 of the funds appropriated under section 2 of this act shall
18 submit detailed funds status and project status reports to
19 the Congress of the Federated States of Micronesia at the
20 beginning of each quarter of each fiscal year until the
21 funds appropriated thereunder are fully expended. The
22 allottee of the funds appropriated under subsection (15) of
23 section 1 and under section 4 of this act shall be the
24 Governor of Pohnpei State. The allottee of the funds
25 appropriated under subsection (1) of section 1 of this act

1 shall be the Pohnpei State PTA. The allottee of the funds
2 appropriated under subsection (2) of section 1 of this act
3 shall be the Mayor of Kolonia Town. The allottee of the
4 funds appropriated under subsections (3), (17) and (18)
5 of section 1 of this act shall be the Chief Magistrate of
6 Sokehs Municipality. The allottee of the funds
7 appropriated under subsections (4), (14), (16) and (19) of
8 section 1 of this act ~~and under section 3 of this act~~ shall
9 be the Pohnpei Community Action Agency. The allottee of
10 the funds appropriated under subsection (5) of section 1 of
11 this act shall be the Luhkenkolwof of Sapwuahfik
12 Municipality. The allottees shall be responsible for
13 ensuring that these funds, or so much thereof as may be
14 necessary, are used solely for the purposes specified in
15 this act, and that no obligations are incurred in excess
16 the sum appropriated. The authority of the allottees to
17 obligate funds appropriated by this act shall not lapse."

18 Section 2. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its becoming
20 law without such approval.
