A BILL FOR AN ACT

To further amend Public Law No. 5-80, as amended, by further amending section 3, as amended by Public Laws Nos. 6-34, 7-15, 7-52, 7-94 and 8-1, for the purpose of changing the allottee of funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:


1 Section 1. Section 3 of Public Law No. 5-80, as amended by
2 Public Laws Nos. 6-34, 7-15, 7-52, 7-94 and 8-1, is hereby further
3 amended to read as follows:

4 "Section 3. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in
6 accordance with applicable law, including, but not limited
7 to, the Financial Management Act of 1979. The allottee of
8 the funds appropriated under section 2 of this act shall
9 be the Governor of the State of Kosrae; except, however,
10 that the allottee of the funds appropriated under
11 subsections (1), ~~(2)~~ ~~(3)~~ ~~(4)~~ ~~(5)~~ ~~(6)~~ ~~(7)~~
12 ~~(8)~~ ~~(9)~~ ~~(10)~~ ~~(11)~~ ~~(12)~~ ~~(13)~~ ~~(14)~~ ~~(15)~~
13 ~~(16)~~ ~~(17)~~ (6), (7) (11) and (12) of section 2 of this
14 act shall be the Chairman of the Kosrae State Commission
15 on Improvement Projects, the allottee of the funds
16 appropriated under subsection (2) of section 2 of this act
17 shall be the Mayor of Lelu Municipality, the allottee of the
18 funds appropriated under subsection (3) of section 2 of
19 this act shall be the Mayor of Tafunsak Municipality, the
20 allottee of the funds appropriated under subsection~~s~~ (4) ~~(j)~~
21 ~~and~~ ~~(k)~~ of section 2 of this act shall be the Mayor of
22 Malem Municipality, ~~and that~~ the allottee of the funds
23 appropriated under subsection (5) ~~(b)~~ of section 2 of this
24 act shall be the Mayor of Utwe Municipality, and the
25 allottee of the funds appropriated under subsection (7) of

1 section 2 of this act shall be the President of the
 2 Federated States of Micronesia. Each allottee shall be
 3 responsible for ensuring that these funds, or so much
 4 thereof as may be necessary, are used solely for the
 5 purposes specified in this act, and that no obligations are
 6 incurred in excess of the sum appropriated. The authority
 7 of the allottees to obligate funds appropriated by this act
 8 shall not lapse until expended."

9 Section 2. This act shall become law upon approval by the
 10 President of the Federated States of Micronesia or upon its becoming
 11 law without such approval.
