A BILL FOR AN ACT

To amend Title 52 of the Code of the Federated States of Micronesia, as amended, by amending sections 206 and 207 clarifying the compensation structure for citizens of the Federated States of Micronesia who have achieved advanced professional status and for United States citizens hired under a prime contract, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 206 of Title 52 of the Coded of the Federated
2 States of Micronesia, as amended, is hereby further amended to read as
3 follows:

4 Section 206. Compensation of employees who are citizens of the
5 ~~Trust Territory~~ Federated States of Micronesia.

6 (1) Except as otherwise hereinafter provided, employees who
7 are citizens of the ~~Trust Territory~~ Federated State of Micronesia
8 shall receive as compensation a base salary as provided in
9 section 205 of this chapter.

10 (2) Notwithstanding the provisions of subsection (1) of this
11 section, any employee covered under the provisions thereof who
12 has achieved advanced professional status through obtaining an
13 earned professional degree in law, an earned doctorate in any
14 other field, or an earned degree in professional engineering
15 awarded on completion of a four-year course from an accredited
16 United States university or any other college or university which
17 is accredited by the competent authority in the jurisdiction
18 where the college or university is located, and who is employed
19 in a position having a requirement for such a degree, shall
20 receive, in addition to the base salary for the position, ~~the~~
21 ~~United States market to provide~~ a premium not to exceed one-hundred-
22 fifty percent of ~~of~~ the pay level and step of the position.

23 (3) Notwithstanding the provisions (1) of this
24 section, any employee covered under the provisions thereof who is
25 assigned to permanent duty station outside the ~~Trust Territory~~

1 Federated States of Micronesia shall receive, in addition to a
 2 base salary, a foreign-service premium which shall be identical
 3 with the market-place premium for the country where the duty
 4 station is located and for the pay level and step of the
 5 position.

6 Section 207. Compensation of employees who are citizens of the
 7 United States.

8 (1) Employees who are citizens of the United States and who
 9 are recruited and hired under a prime contract shall receive the
 10 following compensation:

11 (a) a base salary as provided in section 205 of
 12 this chapter; and

13 (b) a ~~market-place~~ premium ~~which shall be the rate~~
 14 ~~established in a table prepared by the personnel officer~~ not to
 15 exceed one-hundred-fifty percent of his or her base salary as
 16 provided in section 205 of this chapter.

17 (2) Employees who are citizens of the United States and who
 18 are not covered by the provisions of subsection (1) of this
 19 section shall received the same base salary and shall be eligible
 20 for the same premiums, differentials, and allowances as employees
 21 who are citizens of the ~~Trust Territory~~ Federated States of
 22 Micronesia in like positions.


