A BILL FOR AN ACT

To further amend Public Law No. 8-18, as amended by Public Laws Nos. 8-39, 8-44, 8-51 and 8-73, by further amending section 2, as amended by Public Law No. 8-51, to appropriate the sum of \$186,705 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, as supplemental funding for the operations of the legislative branch; by further amending section 15, as amended by Public Law No. 8-39, to raise the overtime ceiling for the Congress; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-18, as amended by Public
2 Law No. 8-51, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of ~~\$2,842,405~~ 2,842,405, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund of the
6 Federated States of Micronesia for the fiscal year ending
7 September 30, 1994, for the operations of the legislative branch
8 of the National Government of the Federated States of Micronesia
9 during fiscal year 1994. The sum appropriated by this section
10 shall be apportioned as follows:
