A BILL FOR AN ACT

To amend Congressional Act No. 8-56, "an act to appropriate the sum of \$10,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, to fund public projects in the four States, and for other purposes.", which became law on May 12, 1994 when the Congress pursuant to article IX, section 2(q) of the Constitution of the Federated States of Micronesia overrode the veto of the President, by amending section 2 to change the use of funds previously appropriated therein, by amending section 3 to change the allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Congressional Act No. 8-56 is hereby
2 amended to read as follows:

3 "Section 2. The funds appropriated under section 1 of this

20 Section 2. Section 3 of Congressional Act No. 8-56 is hereby amended
 21 to read as follows:

22 "Section 3. All funds appropriated by this act shall be
 23 allotted, managed, administered, and accounted for in accordance
 24 with applicable law, including, but not limited to, the
 25 Financial Management Act of 1979. The allottee of the

1 funds appropriated under subsection (1)(a) of section 2 of this
2 act shall be the PWP Development Authority. The allottee of the
3 funds appropriated under subsections (1)(b)(i), (1)(b)(ii),
4 (1)(b)(iii), and (1)(b)(iv) of section 2 of this act shall be the
5 Mayor of Fono. The allottee of the funds appropriated under
6 subsections (1)(b)(v), (1)(b)(vi), and (1)(b)(vii) of section 2
7 of this act shall be the Mayor of Pis-Paneu. The allottee of
8 the funds appropriated under subsections (1)(b)(viii),
9 (1)(b)(ix), (1)(b)(x), and (1)(b)(xi) of section 2 of this act
10 shall be the Mayor of Weno. The allottee of the funds
11 appropriated under subsections (1)(b)(xii), (1)(b)(xiii),
12 (1)(b)(xiv), (1)(b)(xv), and (1)(b)(xvi) of section 2 of this act
13 shall be the Weno Projects Coordinator. The allottee of the
14 funds appropriated under subsections (1)(e)(i), (1)(e)(ii), and
15 (1)(e)(iii) of section 2 of this act shall be the Executive
16 Director of the Hall Development Authority. The allottee of the
17 funds appropriated under subsections (1)(e)(iv), (1)(e)(v),
18 and (1)(e)(vi) of section 2 of this act shall be the Weito
19 Development Authority. The allottee of the funds appropriated
20 under subsections (1)(e)(vii), (1)(e)(viii), (1)(e)(ix),
21 (1)(e)(x), and (1)(e)(xi) of section 2 of this act shall be the
22 Pattiw Development Authority. The allottee of the funds
23 appropriated under subsections (2)(c), (2)(d), (2)(e), and (2)(f)
24 of section 2 of this act shall be the Pohnpei Community Action
25 Agency. The allottee of the funds appropriated under subsection

1 (2)(a) of section 2 of this act pertaining to Kolonia shall be
2 the Mayor of Kolonia Town; all other funds appropriated under
3 subsection (2)(a) of section 2 shall be allotted by the Pohnpei
4 Community Action Agency. The allottee of the funds appropriated
5 under subsection (2)(b), (4)(b), (4)(c), (4)(d), (4)(e), (4)(f),
6 (4)(g), (4)(h), and (4)(i) of section 2 of this act shall be the
7 President of the Federated States of Micronesia. The allottee
8 of the funds appropriated under subsection (4)(a) of section 2
9 of this act shall be the Chairman of the Kosrae Sports Council.
10 The allottee of the funds appropriated under subsection (4)(j)
11 of section 2 of this act shall be the Mayor of the Lelu
12 Municipal Government. The allottee of the funds appropriated
13 under subsection (4)(k) of section 2 of this act shall be the
14 Mayor of the Malem Municipal government. The allottee of the
15 funds appropriated under subsection (4)(l) of section 2 of this
16 act shall be the Mayor of the Utwe Municipal government. The
17 allottee of the funds appropriated under subsection (4)(m) of
18 section 2 of this act shall be the Mayor of the Tafunsak
19 Municipal Government. The allottees shall be responsible for
20 ensuring that these funds, or so much thereof as may be
21 necessary, are used solely for the purposes specified in this
22 act, and that no obligations are incurred in excess of the sum
23 appropriated. The authority of the allottees to obligate funds
24 appropriated by this act shall not lapse."
