A BILL FOR AN ACT

To appropriate the sum of \$519,400 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of reappropriating certain funds which lapsed September 30, 1994, under Public Law No. 7-117, as amended, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$104,400, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1995, for the
4 purpose of constructing and/or improving the Sokehs circumferential road and
5 the lohl road in Pohnpei State. The sum appropriated under this section shall
6 be apportioned as follows:

- 7 (1) Sokehs circumferential road\$ 4,400
- 8 (2) lohl road 100,000

9 Section 2. The sum of \$206,000, or so much thereof as may be
10 necessary, is hereby appropriated from the General Fund of the Federated
11 States of Micronesia for the fiscal year ending September 30, 1995, for the
12 purpose of constructing and/or improving roads in the Kitti and Madolenihmw
13 Municipalities in Pohnpei State.

- 15 (a) Temwen road.....\$ 25,000
- 16 (b) Lohd Pah..... 50,000
- 17 (c) Senpehn road..... 30,000
- 18 (d) Madolenihmw road projects..... 35,000
- 19 (2) Kitti
- 20 (a) Kepine road..... 51,000
- 21 (b) Pehlehg Pah..... 8,000
- 22 (c) Paies road..... 7,000

23 Section 3. The sum of \$209,000, or so much thereof as may be
24 necessary, is hereby appropriated from the General Fund of the Federated
25 States of Micronesia for the fiscal year ending September 30, 1995, for the

1 purpose of constructing and/or improving roads in Nett, U, Pingelap and
2 Mwoakilloa.

3 Section 4. All funds appropriated by this act shall be allotted, managed,
4 administered, and accounted for in accordance with applicable law, including,
5 but not limited to, the Financial Management Act of the 1979. The allottee of
6 the funds appropriated under sections 1 and 2 of this act shall be the President
7 of the Federated States of Micronesia or the President's designee. The allottee
8 of the funds appropriated under section 3 of this act shall be the Pohnpei
9 Transportation Authority. The allottees shall be responsible for ensuring that
10 these funds, or so much thereof as may be necessary, are used solely for the
11 purposes specified in this act, and that no obligations are incurred in excess of
12 the sum appropriated. The authority of the allottees to obligate funds
13 appropriated by this act shall not lapse.

14 Section 5. This act shall become law upon approval by the President of
15 the Federated States of Micronesia or upon its becoming law without such
16 approval.
