A BILL FOR AN ACT

To appropriate the sum of \$3,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for medical supplies, equipment and referral programs in all of the four States of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The sum of \$1,500,000, or so much thereof as may be

2 necessary, is hereby appropriated from the General Fund of the Federated

3 States of Micronesia for the fiscal year ending September 30, 1995, for medical

4 supplies, equipment and referral programs in the State of Chuuk.

5 Section 2. The sum of \$1,000,000, or so much thereof as may be

necessary, is hereby appropriated from the General Fund of the Federated

States of Micronesia for the fiscal year ending September 30, 1995, for medical

supplies, equipment and referral programs in the State of Pohnpei.

9 Section 3. The sum of \$300,000, or so much thereof as may be

necessary, is hereby appropriated from the General Fund of the Federated

11 States of Micronesia for the fiscal year ending September 30, 1995, for medical

12 supplies, equipment and referral programs in the State of Yap.

Section 4. The sum of \$200,000, or so much thereof as may be

14 necessary, is hereby appropriated from the General Fund of the Federated

15 States of Micronesia for medical supplies, equipment and referral programs in

16 the State of Kosrae.

17 Section 5. All funds appropriated by this act shall be allotted, managed,

administered, and accounted for in acordance with applicable law, including, but

19 not limited to, the Financial Management Act of 1979. All funds appropriated

20 herein shall not lapse until fully expended. The allottee of funds appropriated

21 under section 1 of this act shall be the Governor of Chuuk State. The allottee

22 of funds appropriated under section 2 of this act shall be the Governor of

23 Pohnpei State. The allottee of funds appropriated under section 3 of this act

shall be the Governor of Yap State. The allottee of funds appropriated under

25 section 4 of this act shall be the Governor of Kosrae State.
