## A BILL FOR AN ACT

To further amend Public Law No. 8-113, as amended by Public Laws Nos. 8-129, 8-139 and 9-002, by further amending section 6, as amended by Public Law No. 8-129, for the purpose of changing the allottee of funds previously appropriated for social and economic development projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

3	under section 3 of this act shall be the Governor of the State
4	of Yap. The allottees shall be responsible for ensuring that
5	these funds, or so much thereof as may be necessary, are used
6	solely for the purposes specified in this act, and that no
7	obligations are incurred in excess of the sum appropriated.
8	The authority of the allottees to obligate funds appropriated
9	by this act shall not lapse."
10	Section 2. This act shall become law upon approval by the
11	President of the Federated States of Micronesia or upon its becoming law
12	without such approval.
