A BILL FOR AN ACT

To amend Public Law No. 8-118, as amended by Public Laws Nos. 8-136 and 8-138, by amending section 3, as amended by Public Law No. 8-138, for the purpose of changing the allottee of funds appropriated for the Fananu airport project in the Northwest Islands district of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 3 of Public Law 8-118, as amended by Public 2 Law No. 8-138, is hereby further amended to read as follows: "Section 3. All funds appropriated by this act shall be 3 allotted, managed, administered, and accounted for in 4 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the 6 funds appropriated under subsection (1) of section 1 of this act shall be the President of the Federated States of 8 Micronesia. The allottee of the funds appropriated under 9 subsection (2) of section 1 of this act shall be the Northern 10 Namoneas Development Authority. The allottee of the funds 11 appropriated under subsection (3) of section 1 of this act 12 shall be the Lower Mortlocks Development Authority.
