CONGRESSIONAL BILL NO. 9-79

AN ACT

To amend Public Law No. 7-107, as amended by Public Laws Nos. 7-133 and 8-29, by amending sections 3 and 4, as amended by Public Law No. 7-133, for the purpose of converting use of the funds appropriated to the Halls, Namonuito, and Western Islands for the Small Scale Fishing Loan Fund to a Small Scale Fishing Project; changing the allottee of those funds; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 7-107, as amended by Public
2	Law No. 7-133, is hereby amended to read as follows:

The allottee of the funds appropriated under subsections (2), (3) 8 and (4) of section 3 of this act shall be the Chuuk Organization 9 of Community Agencies. The allottee of the funds appropriated 10 11 under subsection (5)(a) and (5)(b) of section 3 of this act 12 shall be the Pattiw Development Authority. The allottees shall be responsible for ensuring that these funds, or so much thereof 13 as may be necessary, are used solely for the purposes specified 14 in this act, and that no obligations are incurred in excess of 15 the sum appropriated.
