A BILL FOR AN ACT

To amend Public Law No. 9-30 by amending section 5 for the purpose of appropriating \$16,800 to fund salaries and benefits for a Financial Analyst position, \$13,500 for an office automobile, \$3,000 to purchase a portable computer, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-30 is hereby amended to read 2 as follows: 3 "Section 5. Operating expenses of agencies of the National Government.
