- 5 the National Government agreed to pay to the plaintiff in the
- 6 case of Faw v. the Federated States of Micronesia v. State of
- 7 Yap, FSM Civil Case No. 1992-3002, in settlement thereof.
- 8 Section 2. All funds appropriated by this act shall be
- 9 allotted, managed, administered, and accounted for in accordance
- 10 with applicable law, including, but not limited to, the
- 11 Financial Management Act of 1979, as amended. The allottee
- 12 shall be responsible for ensuring that these funds, or so much
- 13 thereof as may be necessary, are used solely for purposes
- 14 specified in this act, and that no obligations are incurred in
- 15 excess of the sum appropriated. The authority of the allottee
- 16 to obligate funds appropriated by this act shall not lapse.
- 17 Section 3. This act shall become law upon approval by the
- 18 President of the Federated States of Micronesia or upon its
- 19 becoming law without such approval.
