A BILL FOR AN ACT

To appropriate the sum of \$8,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding major infrastructure projects in the four States, as well as certain governmental operations in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$4,000,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the Federated
- 3 States of Micronesia for the fiscal year ending September 30, 1995, for the
- 4 purpose of funding major infrastructure projects for transportation, health
- 5 and educational purposes, and to meet state governmental operational
- 6 expenses, but in no case for travel or vehicles, in the State of Chuuk.
- 7 Section 2. The sum of \$600,000, or so much thereof as may be
- 8 necessary, is hereby appropriated from the General Fund of the Federated
- 9 States of Micronesia for the fiscal year ending September 30, 1995, for the
- 10 purpose of funding major infrastructure projects for transportation, health
- 11 and educational purposes, but in no case for travel or vehicles, in the
- 12 State of Kosrae.
- Section 3. The sum of \$2,500,000, or so much thereof as may be
- 14 necessary, is hereby appropriated from the General Fund of the Federated
- 15 States of Micronesia for the fiscal year ending September 30, 1995, for the
- 16 purpose of funding major infrastructure projects for transportation, health
- 17 and educational purposes, but in no case for travel or vehicles, in the
- 18 State of Pohnpei.
- 19 Section 4. The sum of \$900,000, or so much thereof as may be
- 20 necessary, is hereby appropriated from the General Fund of the Federated
- 21 States of Micronesia for the fiscal year ending September 30, 1995, for the
- 22 purpose of funding major infrastructure projects for transportation, health
- 23 and educational purposes, but no in no case for travel or vehicles, in the
- 24 State of Yap.
- 25 Section 5. All funds appropriated by this act shall be allotted,

1 managed, administered, and accounted for in accordance with applicable law, 2 including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under section 1 of this act shall be the President of the Federated States of Micronesia or the President's designee. 5 The allottee of the funds appropriated under section 2 of this act shall be 6 the Governor of the State of Kosrae or the Governor's designee. The 7 allottee of the funds appropriated under section 3 of this act shall be the 8 Governor of the State of Pohnpei or the Governor's designee. The allottee 9 of the funds appropriated under section 4 of this act shall be the Governor 10 of the State of Yap or the Governor's designee. The allottees shall be 11 responsible for ensuring that these funds, or so much thereof as may be 12 necessary, are used solely for the purposes specified in this act, and that 13 no obligations are incurred in excess of the sum appropriated. The 14 authority of the allottees to obligate funds appropriated by this act shall 15 lapse as of September 30, 1996. Section 6. This act shall become law upon approval by the 16 President of the Federated States of Micronesia or upon its becoming law without such approval. Date: 9-25-95 Introduced by: 20 21 22 23
