All funds appropriated by this act shall be allotted, 2 managed, administered, and accounted for in accordance with applicable 3 law, including, but not limited to, the Financial Management Act of 4 1979. The allottee of the funds appropriated under this act shall be 5 the Chief Justice of the Supreme Court of the Federated States of 6 Micronesia or his designee, who shall be responsible for ensuring that 7 these funds, or so much thereof as may be necessary, are used solely for 8 the purpose specified in this act, and that no obligations are incurred 9 in excess of the sum appropriated. The authority of the allottee to 10 obligate funds appropriated by this act shall lapse as of September 30, 11 1997. 12 Section 3.
