## A BILL FOR AN ACT

To appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of providing funds for consultation and negotiation with the Government of the United States regarding those provisions of the Compact of Free Association which expire on the fifteenth anniversary of its effective date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$100,000, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of
- 3 the Federated States of Micronesia for the fiscal year ending
- 4 September 30, 1997, for the purpose of providing funds for
- 5 consultation and negotiation with the Government of the United
- 6 States regarding those provisions of the Compact of Free
- 7 Association which expire on the fifteenth anniversary of its
- 8 effective date, and for other purposes.
- 9 Section 2. All funds appropriated by this act shall be
- 10 allotted, managed, administered, and accounted for in accordance
- 11 with applicable law, including, but not limited to, the
- 12 Financial Management Act of 1979, as amended. The allottee
- 13 shall be responsible for ensuring that these funds, or so much
- 14 thereof as may be necessary, are used solely for the purpose
- 15 specified in this act, and that no obligations are incurred in
- 16 excess of the sum appropriated. The authority of the allottee
- 17 to obligate funds appropriated by this act shall lapse as of
- 18 September 30, 1997.
- 19 Section 3. This act shall become law upon approval by the
- 20 President of the Federated States of Micronesia or upon its
- 21 becoming law without such approval.

## AN ACT

To appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of providing funds to retain the services of consultants for the purpose of expanding, promoting and improving relations with the Government of the United States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$100,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the Federated
3	States of Micronesia for the fiscal year ending September 30, 1996, for the
4	purpose of providing funds to retain the services of consultants for the
5	purpose of expanding, promoting and improving relations with the Government
6	of the United States.
7	Section 2. All funds appropriated by this act shall be allotted, managed,
8	administered, and accounted for in accordance with applicable law, including,
9	but not limited to, the Financial Management Act of 1979. The allottee shall be
10	responsible for ensuring that these funds, or so much thereof as may be
11	necessary, are used solely for the purpose specified in this act, and that no
12	obligations are incurred in excess of the sum appropriated. The authority of
13	the allottee to obligate funds appropriated by this act shall not lapse.
14	Section 3. This act shall become law upon approval by the President of
15	the Federated States of Micronesia or upon its becoming law without such
16	approval.
