A BILL FOR AN ACT

To further amend Public Law No. 8-115, as amended by Public Laws Nos. 9-014, 9-033 and 9-041, by further amending section 3, as amended by Public Law No. 9-014, for the purpose of changing the use of funds from a dispensary to road construction in Nett Municipality, and by amending section 5, as amended by Public Laws Nos. 9-033 and 9-041, by changing the allottee of those funds to the Pohnpei Transportation Authority, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 8-115, as amended by
2	Public Law No. 9-014, is hereby further amended to read as follows:
3	"Section 3. The sum of \$180,000, or so much thereof as may
4	be necessary, is hereby appropriated from the General Fund
5	of the Federated States of Micronesia for the fiscal year
6	ending September 30, 1995, for the purpose of financing
7	improvements to the water supply system in Sokehs
8	Municipality and the road construction of a super
9	dispensary in Nett Municipality in the State of Pohnpei.
10	The sum of \$180,000 is further apportioned as follows:
11	(1) Sokehs Municipality\$100,000
12	(2) Road construction, Nett Municipality 80,000"
13	Section 2. Section 5 of Public Law No. 8-115, as amended by
14	Public Laws Nos. 9-033 and 9-041 is hereby further amended to read as
15	follows:
16	"Section 5. All funds appropriated by this act shall be
17	allotted, managed, administered, and accounted for in
18	accordance with applicable law, including, but not limited
19	to, the Financial Management Act of 1979. The allottee of
20	the funds appropriated by subsections (1) and (6) of
21	section 1 of this act shall be the Chuuk State Director of
22	Health Services. The allottee of the funds appropriated by
23	subsection (2) of section 1 of this act shall be the
24	Southern Namoneas Development Authority. The allottee of
25	the funds appropriated by subsection (3) of section 1 of

1	this act shall be the Northern Namoneas Development
2	Authority. The allottee of the funds appropriated by
3	subsection (4) of section 1 of this act shall be the
4	Secretary of the Department of Health Services of the
5	Federated States of Micronesia or his designee. The
6	allottee of the funds appropriated by subsection (5) of
7	section 1 of this act shall be the Pattiw Development
8	Authority. The allottee of the funds appropriated by
9	section 2 of this act shall be the Governor of Kosrae or
10	his designee. The allottee of the funds appropriated by
11	subsection (2) of section 3 of this act shall be the
12	Pohnpei Transportation Authority. The allottee of all
13	other funds appropriated by this act shall be the President
14	of the Federated States of Micronesia or his designee. The
15	allottees shall be responsible for ensuring that these
16	funds, or so much thereof as may be necessary, are used
17	solely for the purpose specified in this act, and that no
18	obligations are incurred in excess of the sum appropriated.
19	The authority of the allottees to obligate funds
20	appropriated by this act shall not lapse."
