A BILL FOR AN ACT

To amend Public Law No. 9-095, concerning primary and secondary schools, by amending sections 1,2 and 3, and by adding new sections 3 and 4, to further apportion the funds appropriated therein for the State of Chuuk, to designate new allottees and to make certain clarifications regarding the duties of the allottees, to set forth the appropriations for other States in separate sections, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESI
1	Section 1. Section 1 of Public Law No. 9-095 is hereby
2	amended to read as follows:
3	"Section 1. The sum of \$2/1600/6660 850,000, or so much
4	thereof as may be necessary, is hereby appropriated
5	from the General Fund of the Federated States of
6	Micronesia for the fiscal year ending September 30,
7.	1997, for the purpose of construction and other needs
8	of primary and secondary schools in the State of
9	Chuuk. The funds appropriated by this section shall
10	be apportioned as follows:

14	Section 4. Public Law No. 9-095 is hereby amended by

17	as may be necessary, is hereby appropriated from the
18	General Fund of the Federated States of Micronesia for
L9	the fiscal year ending September 30, 1997, for the

22	Section 5. Section 3 of Public Law No. 9-095 is hereby
23	amended to read as follows:
24	"Section 3 5. All funds appropriated by this act

accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (1) of section 1 of this act shall be the Governor of the State of Chuuk. The allottee of the funds appropriated under subsection (2) of section 1 of this act shall be the Toleisom Authority. The allottee of the funds appropriated under subsection (3) of section 1 of this act shall be the Southern Namoneas Development Authority. The allottee of the funds appropriated under subsection (4) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (5) of section 1 of this act shall be the Mortlocks Development Authority. The allottee of the funds appropriated under subsection (6) of section 1 of this act shall be the Pattiw Development Authority. The allottee of the all other funds appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee. allottees shall be responsible for ensuring that these funds, or so much thereof as may be

necessary, are used solely for the purpose 1 specified in this act, abd that no obligations 2 are incurred in excess of the sum appropriated. 3 and that no obligations are incurred until after consultation **vith** between the Congressional Delegation and the allottees. The authority of 6 the allottees to obligate funds appropriated by 7 this act shall not lapse." Section 6.
