A BILL FOR AN ACT

To appropriate the sum of \$188,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, as a reappropriation of lapsed funds for construction, repair, renovation, expansion or other improvement to the medical facilities or acquisition of supplies or equipment in the Northwest Islands, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$188,000, or so much thereof as may be				
2	necessary, is hereby appropriated from the General Fund of the Federated				
3	States of Micronesia for the fiscal year ending September 30, 1997, as a				
4	reappropriation of lapsed funds for construction, repair, renovation,				
5	expansion or other improvement to the medical facilities or acquisition of				
6	supplies or equipment in the Northwest Islands. None of the funds made				
7	available by this act may be used for travel. The funds appropriated by				
8	this section shall be apportioned as follows:

21	Section 2. All funds appropriated by this act shall be allotted,				
22	managed, administered, and accounted for in accordance with applicable				
23	law, including, but not limited to, the Financial Management Act of 1979.				
24	The allottee of the funds appropriated under subsection (1) of section 1 of				
25	this act shall be the Hall Islands Development Authority. The allottee of the				

1	funds appropriated under subsection (2) of section 1 of this act shall be the				
2	Nomunwito Development Authority. The allottee of the funds appropriated				
3	under subsection (3) of section 1 of this act shall be the Northwest Islands				
4	Project Coordinator. The allottees shall be responsible for ensuring that				
5	these funds, or so much thereof as may be necessary, are used solely for				
6	the purpose specified in this act, and that no obligations are incurred in				
7	excess of the sum appropriated. The authority of the allottee to obligate				
8	funds appropriated by this act shall lapse as of September 30, 1998.				
. 9	Section 3. This act shall become law upon approval by the President				
10	of the Federated States of Micronesia or upon its becoming law without				
11	such approval.
