## A BILL FOR AN ACT

To further amend Public Law No. 8-93, as amended by Public Laws Nos. 8-98, 8-123, 8-137, 9-020, and 9-098, by further amending section 2, as amended by Public Laws Nos. 8-98, 8-123, 8-137, 9-020, and 9-098, for the purpose of changing an allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 8-93, as amended

2 by Public Laws Nos. 8-98, 8-123, 8-137, 9-020, and 9-098, is

3 hereby further amended to read as follows: "Section 2. All funds appropriated by this act 4 shall be allotted, managed, administered and 5 accounted for in accordance with applicable law, 6 including, but not limited to, the Financial 7 Management Act of 1979. The allottee of the funds appropriated under subsections (1)(a)(i), 9 (1)(a)(ii), and (1)(a)(iii) of section 1 of this act 10 shall be the Tolensom Authority. The allottee of 11 the funds appropriated under subsection (1)(b) of 12 section 1 of this act shall be the Northern Namoneas 13 Development Authority. The alloctee of the funds 14 appropriated under subsection (1)(c) of section 1 of 15 this act shall be the Southern Namoneas Development 16 Authority. The allottee of the funds appropriated 17 under subsection (1)(d)(i) and (1)(d)(ii) of section 18 1 of this act shall be the Northwest Islands Project 19 Coordinator FAMVIMIPHYFIAMMANIAMENTALE. 20 allottee of the funds appropriated under subsection 21 (1)(e)(xiii) of section 1 of this act shall be the 22 Lower Mortlocks Development Authority. The allottee 23 of the funds appropriated under subsection (4) of 24 section 1 of this act shall be the Governor of the 25

State of Yap or his designee. The allottee of all 1 other funds appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purposes specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottees to 9 obligate funds appropriated by this act shall not 10 11 lapse." Section 2.
