## A BILL FOR AN ACT

To further amend Public Law No. 8-113, as amended by Public Laws Nos. 8-129, 8-139, 9-002, 9-036, and 9-124, by further amending section 1, as amended by Public Laws Nos. 8-129 and 9-036, to modify the use of funds appropriated for the Mortlocks district of Chuuk State, by further amending section 6, as amended by Public Laws Nos. 8-129 and 9-036, for the purpose of setting September 30, 1998, as the lapse date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

9	"Section 6. All funds appropriated by this act shall be
10	allotted, managed, administered, and accounted for in
11	accordance with applicable law, including, but not limited to,
12	the Financial Management Act of 1979. The allottee of the
L3	funds appropriated under subsection (1)(a) of section 1 of
L <b>4</b>	this act shall be the Mayor of Udot. The allottee of the
L5	funds appropriated under subsection (1)(b) of section 1 of
L 6	this act shall be the Mayor of Tolensom. The allottee of the
L7	funds appropriated by subsection (2) of section 1 of this act
18	shall be the Southern Namoneas Authority. The allottee of the
19	funds appropriated by subsection (3) of section 1 of this act
20	shall be the Northern Namoneas Development Authority. The
21	allottee of the funds appropriated by subsection (4) of
22	section 1 of this act shall be the Lower Mortlocks Development
23	Authority. The allottee of the funds appropriated by
24	subsection (5)(a) of section 1 of this act shall be the Pattiw
25	Development Authority. The allottee of the funds appropriated

by subsection (6) of section 1 of this act shall be the 1 Executive Director of the Chuuk Organization for Community 2 Action. The allottee of the funds appropriated by subsection 3 (7) of section 1 of this act shall be the Governor of Chuuk State. The allottee of the funds appropriated under 5 subsection (8) of section 1 of this act shall be the Speaker of the Congress of the Federated States of Micronesia. The allottee of the funds appropriated by sections 2, 4 and 5 of this act shall be the President of the Federated States of Micronesia, or the President's designee. The allottee of the 10 funds appropriated under section 3 of this act shall be the 11 Governor of the State of Yap. The allottees shall be 12 responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purposes 14 specified in this act, and that no obligations are incurred in 15 excess of the sum appropriated. The authority of the 16 allottees to obligate funds appropriated by this act shall 17 ### lapse as of September 30, 1998." 18 Section 3. This act shall become law upon approval by the 19 President of the Federated States of Micronesia or upon its becoming law 20 without such approval. 21 Date: 3/17/97 Introduced by:
