AN ACT

To further amend Public Law No. 5-80, as amended, by further amending section 2, as amended by Public Laws Nos. 5-108, 6-34, 7-50, 7-65, 7-94, 7-134, 8-1 and 8-68, to change the use of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 5-80, as amended by Public Laws Nos. 5-108, 6-34, 7-50, 7-65, 7-94, 7-134, 8-1 and 8-68, is hereby further amended to read as follows:
