## **PUBLIC LAW NO. 9-093**

## AN ACT

To further amend Public Law No. 6-74, as amended, funding for public projects in the State of Pohnpei, by further amending section 2, as amended by Public Law No. 7-71, to modify the use of funds previously appropriated therein, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 6-74, as amended by Public Law No. 7-71, is hereby further amended to read as follows:

"Section 2. Madolenihmw and Kitti public projects. The sum of \$425,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding certain public projects in Madolenihmw and Kitti, Pohnpei State. The sum appropriated by this section shall be apportioned as follows:
