C.D.2, C.D.3 PUBLIC LAW NO. 9-103

AN ACT

To amend Public Law No. 9-095, concerning primary and secondary schools, by amending sections 1, 2 and 3, and by adding new sections 3 and 4, to appropriate an additional \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, to provide funding for school needs in the States, to further modify and expand the uses of certain of the funds appropriated therein, to designate new allottees and to make certain clarifications regarding the duties of the allottees, to set forth the appropriations for the States in separate sections, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 1 of Public Law No. 9-095 is hereby amended to read as follows:

> "Section 1. The sum of \$1,000,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of construction and other needs of primary and secondary schools, for assistance to post secondary students, and for other youth development needs in the State of Chuuk. The funds appropriated by this section shall be apportioned as follows:

(1) Saramen Chuuk Academy.....\$ 50,000

(2) Faichuk schools

(a)Classroom improvement,

renovation and other school needs 70,000

- (b)Site leases 60,000
- (c)Youth activities 10,000
- (d)School-related travel 10,000

(e) Administrative cost and

achievement award 10,000

- (f)Other students' needs 30,000
- (3) Southern Namoneas schools 190,000

Section 2 of Public Law No. 9-095 is hereby amended to read as follows:

"Section 2. The sum of \$800,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of construction and other needs of primary, secondary and post secondary schools in the State of Pohnpei. The funds appropriated by this section shall be apportioned as follows:

- (1) Election district no. 1\$ 225,000
- (2) Election district no. 2..... 225,000
- (3) Election district no. 3..... 200,000

(4) Special education and other education needs 125,000

(5) Assistance to Pohnpeian students

at COM-FSM..... 25,000."

Section 3. Public Law No. 9-095 is hereby amended by adding a new section 3 to read as follows:

"Section 3. The sum of \$450,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of construction and other needs of primary, secondary and post secondary schools, and for assistance of post secondary students in the State of Yap. The funds appropriated by this section shall be apportioned as follows:

Tuition, room and board, for (1)Yap students attending COM-FSM..... \$ 28,700 (2) School needs and improvements (a) Rumuu Elementary School. 100,000 (b) St. Mary's School..... 50,000 (c) Dalip-Binau School renovation 21,300 (d) Outer island schools... 110,000 (3) Yap State special education.. 40,000 ^ of 7

(4) Other education needs 100,000" Section 4. Public Law No. 9-095 is hereby amended by adding a new section 4 to read as follows:

> "Section 4. The sum of \$350,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of construction and other needs of primary, secondary, and post secondary schools in the State of Kosrae. The funds appropriated by this section shall be apportioned as follows:

(1) COM-FSM, Kosrae Campus

(a) Campus construction

supplement.....\$ 25,000

(b) Funding to hire

(2) Instructional materials

(a) Lelu and Sansrik Elementary

(b) Tafunsak and Walung Elementary

Schools..... 47,000

(c) Malem Elementary School... 37,000

(d) Utwa Elementary School..... 32,000

(e) Kosrae High School..... 27,000

(3) Scholarship assistance to COM-FSM

students from Kosrae..... 100,000"

Section 5. Section 3 of Public Law No. 9-095 is hereby amended to read as follows:

"Section 5. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (1) of section 1 of this act shall be the Board of the Saramen Chuuk Academy. The allottee of the funds

appropriated under subsection (2) of section 1 of this act shall be the Toleisom Authority. The allottee of the funds appropriated under subsection (3) of section 1 of this act shall be the Southern Namoneas Development Authority. The allottee of the funds appropriated under subsection (4) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (5) of section 1 of this act shall be the Mortlocks Development Authority. The allottee of the funds appropriated under subsection (6) of section 1 of this act shall be the Pattiw Development Authority. The allottee of the funds appropriated under section 3 of this act shall be the Governor of the State of Yap. The allottee of the funds appropriated under subsection 3 of section 4 of this act shall be the Kosrae State Scholarship Board. The allottee of all other funds appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, that no obligations are incurred in excess of the sum appropriated, and that no obligations are incurred until after consultation between the Congressional Delegation and the allottees. The authority of the allottees to obligate funds appropriated by this act shall not lapse."

Section 6. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
