CONGRESSIONAL BILL NO. 9-326, C.D.1, C.D.2 PUBLIC LAW NO. 9-158

## AN ACT

To further amend Public Law No. 9-100, as amended by Public Laws Nos. 9-104, 9-129 and 9-137, by further amending section 3, as amended by Public Laws Nos. 9-104 and 9-137, to reduce the amount appropriated therein for Election District No. 1 of the State of Pohnpei by \$3,000, and to appropriate the sum of \$3,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of funding emergency assistance to Nukuoro Island, State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 3 of Public Law No. 9-100, as amended by Public Laws Nos. 9-104,

and 9-137, is hereby further amended to read as follows:

"Section 3. The sum of \$4,347,000, or so much thereof as may be necessary, is

hereby appropriated from the General Fund of the Federated States of

Micronesia for the fiscal year ending September 30, 1997, for the purpose of

funding the infrastructure, transportation, and tourism development needs of the

State of Pohnpei. The funds appropriated under this section shall be apportioned

as follows:

(1) To fund infrastructure development needs and

purchase and operation of equipment for transportation needs

(a) District no. 1\$	897,000
(b) District no. 2	
(i) Circumferential road	900,000
(ii) Other infrastructure	
development needs	900,000
(c) District no. 3	800,000
(d) Asphalt patch plant	350,000

(2) Tourism development	
(a) Pohnpei Visitor's Bureau	
operation and promotional programs	250,000
(b) Infrastructure development	
and beautification programs	250,000"
Section 2. The sum of \$3,000, or so much thereof as may be necessary, is hereby	
appropriated from the General Fund of the Federated States of Micronesia for the fiscal year	

ending September 30, 1997, for the purpose of funding emergency assistance to Nukuoro Island, State of Pohnpei.

Section 3. All funds appropriated by section 2 of this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under this act shall be President of the Federated States of Micronesia. The authority of the allottee to obligate funds appropriated by section 2 of this act shall lapse as of September 30, 1998.

Section 4. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
