## A RESOLUTION

Declaring Sherry O'Sullivan, a noncitizen of the Federated States of Micronesia, to be an undesirable alien, and requesting her deportation from the country under the laws of the Federated States of Micronesia.

- 1 WHEREAS, among the responsibilities of the Congress of the 2 Federated States of Micronesia is to secure for the people of the
- 3 Federated States of Micronesia the Constitutional guarantee of a
- 4 free press which disseminates accurate, timely and truthful
- 5 information to the public; and
- 6 WHEREAS, the Members of Congress believe that a free press
- 7 which disseminates accurate, timely and truthful information to
- 8 the public is essential to the Nation's economic, social and
- 9 political development; and
- 10 WHEREAS, the publication issued under the title the FSM
- 11 News, which holds itself out to the public as a source of accurate
- 12 and truthful information, is and has been characterized,
- 13 consistently and over a long period of time, in both the tone and
- 14 content of its reporting, by gross, extreme, careless and
- 15 apparently willfully malicious inaccuracies, distortions, and
- 16 outright falsehoods; and
- WHEREAS, it is the sense of Congress that this course of
- 18 conduct seriously damages and impairs the growth and development
- 19 of a free press in the Federated States of Micronesia, and
- 20 interferes with the dissemination of accurate, truthful and
- 21 unbiased information to the people of the FSM, thereby inflicting
- 22 substantial injury to the public, without protection or privilege,
- 23 and to the Government of the Federated States of Micronesia; and
- 24 WHEREAS, it is further the sense of Congress that the editor
- of the FSM News, identified therein as one Sherry O'Sullivan, is

the individual primarily responsible for the above-described 1 malicious and false content of the publication; and 2 WHEREAS, Sherry O'Sullivan is not a citizen of the Federated 3 States of Micronesia; and 4 WHEREAS, title 50, section 107, subsection (1) (k), provides 5 that the President may deport any noncitizen upon a finding that 6 such person's presence in the Federated States of Micronesia is 7 not in the best interests of the Government; now, therefore, 8 BE IT RESOLVED by the Ninth Congress of the Federated States 9 of Micronesia, Fifth Special Session, 1997, that Sherry O'Sullivan 10 is hereby declared an undesirable alien in the Federated States of 11 Micronesia; and 12 BE IT FURTHER RESOLVED that the President is hereby 13 requested to make a finding, based upon the conduct of Sherry 14 O'Sullivan in her capacity as editor of the FSM News as described 15 above, that her presence in the Federated States of Micronesia is 16 not in the best interest of the people, or the Government, of the 17 Federated States of Micronesia, and that proper measures be taken, 18 thereafter, to lawfully deport Sherry O'Sullivan from the country 19 in an expedient manner; and 20 21 22 23 24 25
