FIRST REGULAR SESSION, 2017 CONGRESSIONAL BILL NO. 20-06, C.D.1, C.D.2

AN ACT

To amend Public Law No. 19-170, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 19-170 is hereby
2	amended to read as follows:
3	"Section 2. Of the sum of \$200,000 appropriated by
4	this act, \$50,000 is apportioned for public projects
5	and social programs in the state of Yap.

Section 2 of Public Law No. 19-170 is hereby amended to read 2 as follows:

"Section 6. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State or his designee. The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 3(a) of this act shall be the Mayor of Utwe Municipal Government or his designee. The allottee of funds appropriated under section 5 of this act shall be the Governor of Chuuk State or his designee. The authority of the

1	allottee to obligate funds appropriated by this
2	act shall lapse on September 30, 2018.
3	Section 3. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its
5	becoming law without such approval.
