

AN ACT

To further amend Public Law No. 20-92, as amended by Public Laws Nos. 20-124, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 2 of Public Law No. 20-92 is hereby  
2 amended to read as follows:

3               "Section 2. Of the \$1,400,000 appropriated under this  
4 act, \$200,000 shall be apportioned for public projects  
5 and social programs in the state of Yap.

6 state of Yap..... . \$       200,000

7               (a) COM-FSM National Campus Yapese  
8 students' financial assistance; PROVIDED THAT,  
9 eligibility is based on students that maintain  
10 at least a 2.00 GPA and enrolled full time       50,000

11              (b) Medical referral for non-insured  
12 patients, and payment of outstanding medical  
13 bills for deceased citizens and transportation  
14 of remains home... .. 100,000

15              (c) Current and prior obligation/debts  
16 of Yapese patients at Palau  
17 National Hospital ..... 50,000"

1       Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
