

A BILL FOR AN ACT

To further amend Public Law No. 18-05, as amended by Public Laws Nos. 18-07, 18-14 and 18-31, by amending sections 3, 4 and 6 thereof, for the purpose of changing the use and allottee of certain funds previously appropriated therein to fund public projects and social programs in the States of Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 18-05, as amended by
2 Public Laws Nos. 18-07 and 18-14, is hereby further amended to
3 read as follows:

4 "Section 3. Of the sum of \$2,500,000 appropriated
5 by this act, \$400,000 is apportioned for Yap State
6 for public projects and social programs.

 24 this act, \$700,000 is apportioned for Pohnpei State for
 25 public projects and social programs.

8 Section 3. Section 6 of Public Law No. 18-05, as amended by
 9 Public Law No. 18-07, is hereby further amended to read as
 10 follows:

11 "Section 6. Allotment and management of funds and
 12 lapse date. All funds appropriated by this act shall be
 13 allotted, managed, administered and accounted for in
 14 accordance with applicable laws, including, but not
 15 limited to, the Financial Management Act of 1979. The
 16 allottee shall be responsible for ensuring that these
 17 funds, or so much thereof as may be necessary, are used
 18 solely for the purpose specified in this act, and that no
 19 obligations are incurred in excess of the sum
 20 appropriated. The allottee of the funds appropriated
 21 under section 3 of this act shall be the Governor of Yap
 22 State. The allottee of funds appropriated under sections
 23 2 and 4 of this act shall be the President of the
 24 Federated States of Micronesia or his designee ,EXCEPT
 25 THAT the allottee of funds appropriated under subsection

1 4(3)(a) of this act shall be the Pohnpei Transportation
2 Authority. The allottee of funds appropriated under
3 subsections 5(1) and 5(3) of this act shall be the
4 Governor of Chuuk State or his designee. The allottee of
5 funds appropriated under subsection 5(2) of section 5 of
6 this act shall be the Mortlock Islands Development
7 Authority. The allottee of funds appropriated under
8 subsection 5(4) of section 5 of this act shall be the
9 Southern Namoneas Development Authority. The allottee of
10 funds appropriated under subsection 5(5) of section 5 of
11 this act shall be the Faichuk Development Authority. The
12 allottee of funds appropriated under subsection 5(6) of
13 section 5 of this act shall be the Northwest Island
14 Development Authority. The authority of the allottee to
15 obligate funds appropriated by this act shall lapse on
16 September 30, 2014."

17 Section 4. This act shall become law upon approval by the
18 President of the Federated States of Micronesia or upon its
19 becoming law without such approval.
