
A BILL FOR AN ACT

To appropriate a supplemental budget of \$20,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, by amending sections 1, and 3 of Public Law No. 18-15, as amended by Public Law No. 18-26 and 18-41, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 18-15, as amended by
2 Public Laws Nos. 18-26 and 18-41, is hereby further amended to
3 read as follows:

4 "Section 1. Title. The title of this act is as
5 follows: To appropriate the sum of [~~\$56,585,943~~
6 \$56,605,943 from the General Fund of the Federated
7 States of Micronesia for the fiscal year ending
8 September 30, 2014, for the purpose of funding the
9 operations of all branches of the National Government of
10 the Federated States of Micronesia, its agencies,
11 various programs, grants, subsidies and contributions
12 and Capital and Human Resources Development. Of the
13 total amount of funds appropriated herein, \$2,400,000
14 shall be deemed to come from funds available under the
15 Amended Compact from the education sector; \$-0- shall be
16 deemed to come from funds available under the Amended
17 Compact from the health sector; \$-0- shall be deemed to
18 come from funds available under the Amended Compact from

1 the infrastructure sector; \$-0- shall be deemed to come
2 from funds available under the Amended Compact from the
3 public sector capacity building; \$-0- shall be deemed to
4 come from funds available under the Amended Compact from
5 the enhanced reporting and accountability sector; and
6 \$1,112,158 shall be deemed to come from funds available
7 under the Supplemental Education Grant. The sum
8 appropriated herein shall be apportioned as follows:"

9 Section 2. Section 3 of Public Law No. 18-15, as amended by
10 Public Laws Nos. 18-25 and 18-41, is hereby further amended to
11 read as follows:

12 "Section 3. Operating Expenses of the Legislative
13 Branch. The sum of [~~\$3,770,228~~] \$3,790,228 or so much
14 thereof as may be necessary, is hereby appropriated from
15 the General Fund of the Federated States of Micronesia
16 for the fiscal year ending September 30, 2014, for the
17 operations of the Legislative Branch of the National
18 Government during fiscal year 2014. The sum
19 appropriated by this section shall be apportioned as
20 follows:

21 (1) Speaker and Members.

22 The sum of [~~\$1,678,771~~] \$1,698,771, or so much thereof
23 as may be necessary, for the operations of the Office of
24 the Speaker and Members of the Congress of the Federated
25 States of Micronesia during fiscal year 2014. The sum

1 appropriated herein shall be apportioned as follows:

8 The sum of \$1,401,457, or so much thereof as may be
 9 necessary, for the operations of the Congress staff
 10 offices during fiscal year 2014. The sum appropriated
 11 herein shall be apportioned as follows:

20 The sum of \$690,000, or so much thereof as may be
 21 necessary, for the operations of the Congress delegation
 22 offices during the fiscal year 2014. Of the amounts
 23 appropriated for contractual services within each
 24 Delegation Office, up to a maximum of \$25,000 per
 25 Member, at the Delegation Offices' discretion, may be

1 used for Member Representation. The sum appropriated is
2 apportioned as follows:
