A BILL FOR AN ACT

To appropriate a supplemental budget of \$210,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, by amending sections 1 and 3 and of Public Law No. 18-15, as amended by Public Laws Nos. 18-26, 18-41 and 18-54, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2           Section 1. Section 1 of Public Law No. 18-15, as amended by  
3 Public Laws Nos. 18-26, 18-41 and 18-54, is hereby further  
4 amended to read as follows:

5           "Section 1. Title. The title of this act is as  
6 follows: To appropriate the sum of \$ [~~58,490,777~~  
7 58,700,771] from the General Fund of the Federated States  
8 of Micronesia for the fiscal year ending September 30,  
9 2014, for the purpose of funding the operations of all  
10 branches of the National Government of the Federated  
11 States of Micronesia, its agencies, various programs,  
12 grants, subsidies and contributions and Capital and  
13 Human Resources Development. Of the total amount of  
14 funds appropriated herein, \$2,437,568 shall be deemed to  
15 come from funds available under the Amended Compact from  
16 the education sector; \$-0- shall be deemed to come from  
17 funds available under the Amended Compact from the  
18 health sector; \$-0- shall be deemed to come from funds  
19 available under the Amended Compact from the

1 infrastructure sector; \$-0- shall be deemed to come from  
2 funds available under the Amended Compact from the  
3 public sector capacity building; \$-0- shall be deemed to  
4 come from funds available under the Amended Compact from  
5 the enhanced reporting and accountability sector; and  
6 \$1,112,158 shall be deemed to come from funds available  
7 under the Supplemental Education Grant. The sum  
8 appropriated herein shall be apportioned as follows:"

9 Section 2. Section 3 of Public Law No. 18-15, as amended by  
10 Public Laws Nos. 18-26, 18-41 and 18-54, is hereby further  
11 amended to read as follows:

12 "Section 3. Operating Expenses of the Legislative  
13 Branch. The sum of \$~~[4,020,228]~~ 4,230,228 or so much  
14 thereof as may be necessary, is hereby appropriated  
15 from the General Fund of the Federated States of  
16 Micronesia for the fiscal year ending September 30,  
17 2014, for the operations of the Legislative Branch of  
18 the National Government during fiscal year 2014. The  
19 sum appropriated by this section shall be apportioned  
20 as follows:

21 (1) Speaker and Members.

22 The sum of \$~~[1,838,771]~~ 1,978,771, or so much thereof as  
23 may be necessary, for the operations of the Office of  
24 the Speaker and Members of the Congress of the Federated  
25 States of Micronesia during fiscal year 2014. The sum

1	appropriated herein shall be apportioned as follows:	
2	Personnel .....	\$ 423,290
3	Travel .....	<del>594,881</del> <u>734,881</u>
4	Contractual Services .....	820,600
5	OCE .....	-0-
6	Fixed Assets .....	-0-

(2) Staff Offices.

The sum of \$1,491,457, or so much thereof as may be necessary, for the operations of the Congress staff offices during fiscal year 2014. The sum appropriated herein shall be apportioned as follows:

12	Personnel .....	\$ 817,059
13	Travel.....	135,252
14	Contractual Services.....	318,146
15	OCE PROVIDED THAT up to \$10,000 may be used to	
16	pay expenses incurred during previous fiscal	
17	years.....	162,000

(3) Congress Delegation Offices.

The sum of \$~~690,000~~ 760,000, or so much thereof as may be necessary, for the operations of the Congress delegation offices during the fiscal year 2014. Of the amounts appropriated for contractual services within each Delegation Office, up to a maximum of \$25,000 per Member, at the Delegation Offices' discretion, may be

1 used for Member Representation. The sum appropriated is  
 2 apportioned as follows:
