A BILL FOR AN ACT

To amend sections 403 and 405 of title 52 of the Code of the Federated States of Micronesia (Annotated), to modify the premium contributions for retired government employees for the National Government Employee's Health Insurance Plan, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 403 of title 52 of the Code of the
- 2 Federated States of Micronesia (Annotated), is hereby amended to

- 4 "Section 403. Eligibility.
- 5 (1) All full-time employees of the National 6 Government of the Federated States of Micronesia shall 7 participate in the plan.
 - (1) Other persons who may participate in the plan:
- 9 (a) The full-time employees of each participating
 10 agency and businesses which has entered into a contract
 11 with the Director, as administrator of the plan, whereby
 12 such agencies or businesses have agreed to participate
 13 in the plan.
 - (b) The dependents of full-time employees of the National Government, participating agencies and participating businesses;
- 17 (c) Members of an employee's household who are
 18 dependent
 19 upon the employee, but are not otherwise defined as

20 "dependents"

under the provisions of this Act, if the employee pays 1 2 100 percent of the premiums for such persons to the 3 plan; 4 (d) Government employees whose State or agency does not participate in the plan, and their dependents, 5 6 if they pay 100 percent of the premiums for themselves 7 and their dependents to the plan; 8 Retired former employees of the National 9 Government of the Federated States of Micronesia, and their dependents, if they pay the percentage of the 10 premium not paid by their employer; 11 12 [(e)](f) Other [F] former enrollees in the plan, 13 and their dependents, if they pay 100 percent of the premiums for themselves and their dependents to the 14 15 plan; and 16 $[\frac{f}{f}]$ (g) Full-time students enrolled at any 17 postsecondary institution in the FSM, if the postsecondary institution has entered into a contract of 18 19 participation with the plan and the students pay 100 20 percent of the premium for themselves to the plan. 21 Section 2. Section 405 of title 52 of the Code of the 22 Federated States of Micronesia (Annotated), is hereby amended to 23 read as follows: 24 "Section 405. Premium contributions. 25 Employees and retired employees participating in the

1	plan shall contribute the percentage of the premium not
2	paid by their employer for insurance under the plan.
3	The National Government of the Federated States of
4	Micronesia shall contribute at least 52 percent of the
5	premium for eligible employees, and retired employees,
6	of the National Government participating in the plan.
7	Any participating agency or participating business shall
8	contribute at least 50 percent of the premium for their
9	employees participating in the plan, or may at their
10	request contract with the Board to contribute more than
11	50 percent."
12	Section 3. This act shall become law upon approval by the
13	President of the Federated Sates of Micronesia or upon its
14	becoming law without such approval.
